## **LEGAL NOTICE TAXPAYERS, TOWN OF STAFFORD**

All persons liable to pay Property Taxes in the Town of STAFFORD are notified that the Second Installment of taxes and motor vehicle taxes on the Supplement list on the Grand List of October 1, 2018 are *due January 1, 2020 and payable without interest through February 3, 2020*.

Failure to pay the tax on or before February 3, 2020 will render the tax delinquent and interest will be charged at the rate of 1+1/2% per month **from the due date** OR a MINIMUM INTEREST OF \$2.00. The higher amount prevails, **AND INTEREST APPLIES SEPARATELY TO THE TOWN AND DISTRICT.**

*A supplemental bill* is for any vehicle registered after October 1, 2018. Vehicles are assessed based on the month they were first registered through September 30, 2019. Check your bill for the applicable code. If this vehicle replaces a vehicle on the regular October 1st Grand List, a credit for that vehicle will show on this bill.
