CRYSTAL LAKE BEACH PASSES – SUMMER 2019

The Ellington Parks and Recreation Commission has set a fee of **\$65.00** Per family for Stafford residents in order to renew or secure a 2019 beach pass.

A total of **50 passes** will be allowed by policy agreement. The residents securing a pass may use the Waterfront on weekdays (12 noon to 7:00 p.m.) And weekends /holidays from 11 a.m. – 7:00 p.m. The actual beach hours will be as follows;

May 25, 26, 27

June 1, 2, 8, 9, 15, 16

Weekend hours only 12noon - 5p.m.

{All providing the weather and staff availability}.

June 17th - August 18th (staff permitting)

11am – 7:00 p.m. Weekends, 12 noon – 7:00 p.m. Weekdays.

Post season: August 19-September 2~ 12 noon -5 p.m. (pending weather &staff)

Families wishing to register for swim lessons may do so, in person, at the Recreation Office (Arbor Commons Building at 31 Arbor Way P.O. Box 187 off of Main Street) beginning May 1st during our regular office hours. [Mondays 8:30am – 6pm, Tuesday-Thursday 8:30am-4pm and Fridays 8:30am – 1:30pm].

The fee for swim lessons is as follows: **\$60.00 for 30-minute class, and \$70.00 for 40-minute class.** Sessions are offered in two-week increments; Mondays through Thursdays if a resident would like a copy of the proposed 2019 schedule they may contact Mary Bartley at the recreation office @ 870-3118 ext. # 2140.

Regarding the beach pass procedures, upon receiving a list of approved Stafford residents, and a check to match, the Ellington Recreation Department will forward the actual beach pass, beach rules and anticipated opening and closing dates to the Stafford Resident.
