2018 Declaration of Personal Property – MV FORM

Return Deadline: November 1, 2018

Assessment Date: October 1, 2018

TO:

1. Filing Requirement – This declaration must be completed annually and filed with the Assessor of the town where personal property is located. **Writing "Same as last year" is not acceptable and subject to 25% penalty.**

2. Taxable Personal Property includes: Structural campsite **site information** (decks and sheds for example), campers, RVs, snowmobiles, trailers, trucks, passenger cars and off-road vehicles. This also includes **any vehicle located in Stafford** but registered in another state or another Connecticut town or any such vehicle not registered.

3. Extension – The Assessor may grant a filing extension for good cause (CGS §12-42). If a request for an extension is needed, you need to contact the Assessor **in writing by November 1, 2018**. If your extension is granted, you will receive a letter from the Assessor.

4. Penalty for late filing – Failure to file timely will result in a **late-filing penalty equal to 25% of the assessment** of the personal property. If this declaration is not returned to the Assessor, it must be assumed that you still own the property and have failed to declare your taxable personal property. This declaration must be filed or postmarked (as defined in C.G.S. Sec 1-2a) no later than November 1, 2018.

5. If you no longer own the personal property that was assessed in your name last year or you have moved the property out of Stafford, you must return this declaration to the Assessor and **provide the name of the new owner or the location where you moved the property**. (The affidavit below is to be used for the sale or relocation of personal property.)
